## TERMS OF ENROLLMENT

1. Fees include food, lodging, linens, blankets, and towels. Medical services beyond those routine supports provided by the resident medical staff must be covered by participant's own insurance.
2. For all summer sessions, tipping is optional, please do so at your own discretion. For the Passover program, the fees do not include gratuities. Tipping is customary for good service. A tipping guideline will be sent to you with your travel information.
3. Round trip door-to-door ground and air transportation from the Fort Lauderdale Airport or the West Palm Beach Airport and charter coach from the Newark International Airport, NJ directly to the Block Center is included in the fee. Door-To-Door service is only available if the entire package is taken. We cannot provide Florida ground transportation for individuals who arrange their own flights or who travel on departure dates other than those specified on this form. No refunds will be made to participants who use their own ground transportation.
4. A Block and Hexter medical form must be submitted 30 days prior to arrival. A blank health form will be sent to you with your bill. Participants must be in general good health. **Participation in the program may be denied if the health form is not received.**
5. I hereby consent and agree to participate in all Associated Camps, Inc. activities including, but not limited to, exhibits, performances, and television, video, radio, and transcribed programs, in each case without compensation, and the Associated Camps and the United Jewish Appeal-Federation of Jewish Philanthropies of New York, Inc., with which the camp is affiliated, may photograph, videotape, or record the undersigned applicant and may use at any time such person's photograph, videotape, or recording and/or name in furtherance of the Associated Camps or UJA Federation's charitable purposes, without being compensated.

7. Fees are set by the Camps' administration and Board of Directors. Participants who cannot afford the published tuition may request financial assistance and must complete a scholarship form. Assistance will be given based upon total annual income and expenses.
8. **Cancellation Policy:** Once your deposit check is cashed, there will be a non-refundable processing fee of **at least \$75 per two-week session per person**. Additional cancellation fees vary depending on how far in advance of your stay the cancellation is received. **All cancellations, including medical, received 21 days or less before vacation are subject to a \$100 charge per two-week session per person. All cancellations, including medical, made in the last week before vacation are subject to a \$150 fee per two-week session per person.** Cancellations must be in writing. There are no reductions for late arrivals, early departures, or "no shows" - regardless of reason.  
**Important Notice Regarding Airline Tickets And Cancellations:** Your airline tickets are non-refundable once they are issued by the airline. Tickets will be issued 90 days prior to your scheduled departure. If you cancel your trip within 90 days of departure, you will not receive a refund of the cost of the airline ticket. We will however, send you the ticket for future use. The ticket must be rebooked for a new travel date no later than midnight of the original travel date. **All changes in travel dates after tickets are issued are subject to a change fee of at least \$150 as imposed by the airline. Due to the uncertainty of future airline prices, we reserve the right to add a surcharge should prices increase beyond budgeted amounts. The cost of checked baggage shall be the responsibility of the participant and must be paid for at check-in.**
9. Participants who do not belong to a Jewish Community Center or YM-YWHA must pay a **non-refundable \$35 registration processing fee**. This check will be collected by the sponsoring agency (the one providing your ground transport) and is to be made payable directly to the JCC.

### ENROLLMENT PROCEDURES

1. To reserve a room for Summer 2012, a deposit according to the above schedule is required.
2. **Early Bird Discount Amounts: Balances paid in full by December 31, 2011 will receive a discount of \$35 per person per each two-week session. Accounts not paid in full by December 31, 2011 will not receive a discount.**
3. Persons not paid in full by December 31, 2011 will be re-billed at the 2012 rate as quoted on the front of this form. The due date for non-early bird payments is 90 days prior to your scheduled departure. A late payment fee of \$25 per each two-week session will be imposed for unpaid balances more than 14 days late.
4. We reserve the right to change the rooms of anyone not paid in full by December 31, 2011
